8. Reports

- 8.1. **Financial Report -**The Treasurer presented his report, which included the SSA Grant and which is as attached at Annex A. Resolved that the financial report be accepted. It was suggested that the Investment fund objective be indexed half yearly
- 8.2. **Meeting with SRV –** The President reported on attendance at two SRV meetings on 22nd February and 8th April 2011

9. General Business

- 9.1. Victorian Croquet Centre:
 - 9.1.1. **Maintenance Matters:** Resolved that Snow Evans be contracted to carry out garden and minor maintenance at VCC, at a rate to be negotiated by CoM.
 - 9.1.2. **VCC Committee:** Resolved that a VCC Committee be formed, in accordance with the discussion paper, to oversee all aspects of VCC and that the President appoint members and determine their duties.
- 9.2. **Coaching:** P Moore reported on progress towards a Coaching program, which will be presented to the May CoM meeting.
- 9.3. VCA Travel Reimbursement Policy Resolved that the draft policy be accepted with the following amendments; Para 3.2 change "expected" to "encouraged", delete all after "when offered".
- 9.4. Tournament Play in Victoria: P Moore & T Devlin reported on progress of committee. Agreed that committee continue work and report to next Council meeting with a report on Tournaments and a separate one on Marketing Croquet in Victoria.

9.5. Bayside CA -

- 9.5.1. **Elsternwick CC** Resolved that Secretary acknowledge Elsternwick correspondence, pointing out that the insufficient details of the club's financial circumstances and planned expenditure of the funds requested, means that VCA is unable to assist without further information.
 - In answer to a query as to whether VCA has a policy for assistance to clubs in difficulties, the Treasurer replied that there was precedent, which was to provide experienced personnel to review the situation and suggest remedies and to provide in-kind assistance.
- 9.5.2. **Handicapping at Club Internal Competitions** This matter was referred to the Handicap Committee.
- 9.5.3. **Centennial Celebrations** Brighton celebrated its centenary on 20th March 2011, Sandringham on 23th March 2011 & Elsternwick is to celebrate its centenary on 30th April 2011.

A motion that "VCA provide a nominal amount of \$500 to clubs celebrating their centenary" was lost.

Resolved that VCA present clubs reaching their centenary with an appropriate memento.

Resolved that a board be displayed in VCC showing clubs that have reached their centenary.

P Moore offered to donate the board.

- 9.5.4. **Victorian Seniors Week Publicity:** Resolved that VCA and all Victorian clubs be listed in the annual Victorian Seniors Week publications. Secretary to organise.
- 9.6. **Possible Disciplinary Tribunal:** The Vice President assumed the chair for this item, as the President is named in the correspondence concerning the item, which was tabled and discussed.
 - Resolved that the correspondence (less that concerning loss of figurines) be referred to a Disciplinary Tribunal to be appointed, such appointment being delegated to the Vice-President, Secretary and Treasurer. This resolution was passed with three abstentions including those of Mike Cohn and Ken Richardson.
- 9.7. **Malletsports Victoria Magazine:** The Secretary reported on his dealings with a publisher of similar magazines and Roy Palmer reported on his discussions with a free-lance editor. CoM is to continue examining the matter.
- 9.8. **Titles of Appointed Officials:** Resolved that the title of State Directors be changed to State Coordinators.
 - 9.8.1. State Coordinator of Association Croquet: Resolved that Council appoint a State Coordinator of Association Croquet.
 - 9.8.2. **Membership of F&T Committee:** Resolved that the State Coordinators of Association Croquet, Gateball and Golf Croquet be members of the Fixtures & Tournaments Committee.
- 9.9. **VCA AGM** The Secretary reported on his preparations for the 9th June 2011 AGM.
- 9.10. **ACA AGM** The President reported on the 28th March 2011 ACA AGM, noting that all four Notices of Motion put forward by VCA were defeated.
- 9.11. **ACA Association Croquet Championships:** The President reported that at the recent AC championships held in Tasmania;

Stephen Forster (Belmont) won the ACA Gold Medal;

Robert Fletcher (Lismore) won the Men's Championship;

Tricia Devlin (Castlemaine) won the Women's Championship; and

The Victorian team was runner-up in the Eire Cup, after a count-back on the final day.

3. Government State Sporting Association Support Grants (SSASG) 2011/2014:

The grant for the Sports' Development Officer (SDO) has been received and advertising the position has commenced. The focus is on the first four priorities below.

Sport and Recreation_Victoria (SRV) Grants closely follow the priorities in the current VCA Strategic Plan:

- · encouraging and supporting volunteers;
- developing all forms of the game of croquet;
- increasing participation in croquet throughout Victoria;
- marketing croquet as a dynamic and stimulating sport for all ages;
- up to two accredited coaches at each targeted club;
- coaching resources manual;
- increasing the number of referees at each targeted club;
- Tournament Management training sessions including a handbook; &
- promoting efficient and effective club administration and finance operations.

The other grants from SRV for the remaining priorities above will be received by mid-year and the pilot programs are being developed. It is mandated that country regions will be included from the beginning.
