4. **Minutes of the Previous Annual General Meeting held 10th June 2010:**

Resolved that the minutes of the previous Annual General Meeting, held 10th June 2010, be accepted.

9.4. Members. The chair advised that three nominations had been received from Snow Evans, Jim Saunders and Gwen Hamilton for the three vacancies as ordinary members of committee. Resolved that the nominees be approved as Members of the Committee. In accordance with Council's resolution of 9th December 2010, lots were to be drawn to determine which two would serve a two year term and who would serve a one year term. Results were:

9.4.2. One year term – Jim Saunders
