March 2023 FINANCIAL REPORT

The INTERIM Financial reports for year ended 31 March 2023 are attached.

Provided are:

- Summary level Profit and Loss including full year vs budget and prior year and indicative VCA and VCC split
- Balance Sheet
- JBWere Monthly report Summary March 2023

There are some year-end adjustments including some accruals and JBWere final numbers still to be processed, so these reports are interim.

Key points to note:

The Interim Net Operating result for the year is \$134,077 compared to a budget operating deficit of \$64,468 (\$198k difference) and prior year surplus of \$86,960 (\$47k difference). The "cash" result, excluding depreciation, was \$222.9k compared to a budget of \$25.5k.

The interim overall result is a deficit of \$28,124 compared to a budgeted surplus of \$29,531 (\$57k difference).

The key differences in the full year interim result vs budget are:

- Significantly higher investment income than budgeted (\$58k) which is offset by negative market movement (\$162k negative compared to budget of \$94k positive).
- Higher Affiliation fees compared to budget due to increased membership (\$5.8k) and \$12k lower than last year due to a reduction in fee rates during the year.
- Higher catering and bar sales due to increased usage in particular during the MacRobertson Shield and the Eire Cup.
- Lower grant income offset by lower grant expenses.
- Lower Committee and Co-ordinator spend (\$22.6k).
- Lower U21s scholarship spend.
- Lower VCC building costs compared to budget (\$45.9k), mainly relating to Repairs and Maintenance and water costs; and
- Lower court costs (\$25k) mainly due to less fertiliser spend as a result of Seasol sponsorship, and lower court consulting and scarifying costs.

Income

- a) The JB Were investment portfolio income for the month was \$24k and \$199.9k for the full year. The full year Realised and Unrealised Movement in market value of the JB Were portfolio is a decrease of \$28k. This is based on interim numbers and there may be some movement when final figures for year end are provided later this month.
- b) We recorded \$7.9k in ACA Court Hire for the month relating to AC Gold Medal, AC Men's and Women's Championships and Eire Cup.
- c) Other revenue for the month included Affiliation fees for new members since 1 January 2023.

Expenses

- **d)** Expenses for the month included payment to the ACA for Affiliation fees collected on its behalf, Honoraria paid to President, Secretary and Treasurer in accordance with the approved budget and contribution to Croquet Scores of \$1,200.
- e) We also paid \$4.5k for website assistance and accrued JB Were Management fees for the quarter were \$7.2k.
- f) Full year depreciation of plant and equipment of \$5.2k was charged at year end, together with the monthly building depreciation charge of \$6.9k
- g) Other expenses for the month included Repairs and maintenance of \$2.5k and Court costs of \$3.9k.

Balance Sheet

- h) Interim Net Assets at 31 March were \$8,789,841. The movement in Net Assets for the year was a decrease of \$28,124.
- i) See attachment for a summary page of the JB Were portfolio at 31 March showing the value of \$4,731,007, an increase of \$44,457 for the year. This includes \$40k deposited to the portfolio during March, so the net return for the year of Income and capital was \$4,457.
- j) The value of Land and Buildings of \$3,982,904 has decreased by \$61.7k reflecting capital improvements during the year offset by depreciation.
- k) Accounts receivable of \$13.2k includes ACA Hire and Affiliation fees outstanding.
- I) Accounts payable of \$8.5k includes \$7.2k payable to JB Were.

Cash Outlook

The operating bank account balance at 31 March was \$109k, after placing \$40k into the JB Were Investment account as approved at the last Council meeting. This compares to approx. \$119k at the same point last year. There is no foreseeable need to draw down any cash from the investment portfolio for the next 6 months.

Finance sub-committee report - The Finance sub-committee has not met since the last Financial Report.

President's report

BACKGROUND

Under the Constitution, the Committee of Management reports to Council via the President. Under the by-laws, the president is required to represent and promote mallet sports in all its forms throughout Victoria, to chair meetings of Council and CoM, and to attend meetings of sub-committees and working groups ex officio.

UPDATE

1. Matters from the Committee of Management

The March meeting of CoM discussed

- The advantages of appointing committees and appointed officers for a two-year term, consistent with other office-bearers. This proposal is being submitted separately for discussion at this meeting.
- Correspondence in relation to the recent disciplinary tribunal hearing
- The need to update the list of coaches on the Croquet Victoria website to reflect the actual availability of lead coaches

CoM is also trying to find out whether a constitutional change would be needed for Croquet Victoria to pay its Secretary.

2. Promoting mallet sports

The new poster *Looking for a new sport?* Is in demand by other states and will feature in the next *Croquet Gazette.*

Sarina and I are currently liaising with potential commentators for the livestreaming of the last three days of the Australian Open Golf Croquet Singles.

I have participated in an initial discussion and a focus group talking about the impending rebranding of Croquet Australia. A key issue seems to be whether croquet can be presented as both a fun activity and a serious sport.

3. Update on complaints

No new complaints have been received.

As indicated above, a lawyer's letter has been received in relation to the recent Disciplinary Tribunal outcome. Following discussion at and following the last CoM meeting, I responded outlining the process we followed, in line with our constitution, and drawing attention to the provision in the Constitution which states that the decision of a Discipinary Tribunal is not subject to appeal.

Earlier this month I attended a members' meeting at Eastern Park Croquet Club to answer questions on the recent disciplinary tribunal process. One issue that came up in the discussion was the scope of the office-bearers' liability insurance which is incorporated in member insurance via Croquet Australia. It could be useful to clubs to provide information on the components of this insurance.

Sport Integrity Australia / Play by the Rules are offering training for complaint handling, distinct from the training provided for Member Protection Information Officers. Croquet Victoria does not currently have a Complaints Officer; it would be helpful if Directors could encourage anyone interested to undertake the SIA training.

4. Representing mallet sports

On behalf of Croquet Victoria, I recently attended a morning tea at Brighton Croquet Club to present Daphne Alcorn with her Life Member badge and certificate.

I continue to attend the VicSports Zoom briefings for state sporting organisations, regional sport associations, and the Victorian Institute of Sport. Information at these briefings is provided by VicHealth and Sport and Recreation officers, including a member of the SRV COVID team.

An upcoming topic will be the next round of Together More Active funding, which I am reporting on separately.

Also, and again as reported separately, I have been involved in communication with Sport and Recreation Victoria in relation to the current round of Together More Active funding.

5. Liaising with Croquet Australia and other states

I attended the Annual General Meeting of Croquet Australia, where two Croquet Victoria members were elected Directors: Claire Keating (since appointed Treasurer of Croquet Australia) and Sarina Cevaal-Hewitt. Following the AGM there was a facilitated discussion of strategic priorities for croquet in Australia, drawing on the various state association strategic plans.

As Croquet Victoria's representative, I am participating in monthly Zoom meetings between Croquet Australia directors and the Presidents of the State Associations. Most recently we have been discussing arrangements for the Eastern and Western Qualifying Tournaments for the Golf Croquet Over 50s Worlds Championship later this year. I have also participated in a discussion of the pros and cons of the partner selected by Croquet Australia to underpin their website and database. It is looking likely that a different approach will be needed.

6. Attendance at sub-committee meetings

Since the last meeting of Council I have attended a number of sub-committee meetings: Strategic Plan Implementation, the Marketing and Publicity, VCC, Tournaments and Fixtures, AC Selection, GC Selection, and the VCC Futures Working Group.

NEDCA Regional Report

NEDCA has thirteen clubs. We have five clubs who are essentially social clubs. Our region spreads across 213 kilometres (east to west) and 144 kilometres (north to south)

Of note during the past year:

- clubs continue to hold many social days which are very well supported and we expect members of our newest club (Corryong) to attend these this year
- this year we have scheduled an Open Golf Croquet Singles event to be hosted at Benalla.
- we have nine Golf Croquet referees, seven Association Croquet referees and four Ricochet Croquet referees essentially six of the Golf Croquet referees are active within the region, which is not enough to meet demand
- we have nine Golf Croquet coaches, four Association Croquet coaches, three Ricochet Croquet and two Gateball coaches
- members are being invited to compete at Selectors Invitationals
- the NEDCA Facebook page continues is active and growing (232 members)
- our 2023 Association Croquet Country Championships team included two members from other regions. Association Croquet is now only played regularly at two clubs
- NEDCA members continue to play and referee at events hosted at the Victorian Croquet Centre and events throughout the state and interstate
- NEDCA members continue to nominate for Appointed Officers and Sub-Committee membership.

Club Reports

Beechworth

presentations.

Beechworth has 32 members this year, several down from last year but have also gained two new members. New membership has largely come from members encouraging friends to join.

Successes – Beechworth were the winners of NEDCA Pennant in a tight final against Benalla and will again be fielding a team in 2023. This year our club has accepted two players from Wangaratta into our team. Our policy of allowing all players in the handicap range to have the opportunity to participate continues.

Our youngest member, George Walker aged 13 yrs, came first in the Bronze Under 21s VCA competition. George went on to gain a third in the Silver and Gold Under 21's held on the Gold Coast in January.

Grant Assistance – The club received a grant of \$24,000 from Indigo Shire for resurfacing and replanting our second lawn.

The club continues to receive ongoing sponsorship from Indigo Real Estate. The club was successful in gaining TMA grant for 6 days coaching for Novice Competitors. Beechworth has been hosting the TMA workshops led by Maurice Cevaal-Hewitt, with the assistance of Sarina Cevaal-Hewitt and Beechworth Club coach, Allan Holt. Those attending have gained a lot of practical knowledge and are keen to return for the last weekend

Publicity – Beechworth Croquet Club was represented at Beechworth's Volunteers Expo in September 2022. Some interest expressed by those making enquiries.

Visitors from N.S.W.s and other Victorian clubs have been welcomed to play on social days. BCC has hosted 'Come and Try' for: several community groups. Beechworth Exercise Activity & Training group have incorporated croquet in their social get-together twice within the past 12 months and enjoyed the use of our lawns. They commented on the improved quality of our 'Mallets to Share'. Again the benefit of a grant to purchase 16 new mallets.

Beechworth Croquet Club will be celebrating 'World Croquet Day' on the 1st of May as we did last year with lunch and a game or two of croquet.

Benalla

Benalla CC is going strong with a core group of regular attendees playing both socially and in regional social days and competition. Our membership has declined from pre-COVID days due mainly to ill health of playing or caring duties. We have one new registered member this year. Our 'Come & Try' days earlier this year were not as successful as in the past. Increasing our membership remains an important project.

Benalla suffered through the floods of last October necessitating huge clean up efforts. Our courts were under water and / or unplayable for a few weeks. Fortunately, no major damage was evident in the clubhouse.

Events- Benalla CC holds two Social Day events each year as our major fundraisers. Our November 2022 event following the floods had decreased attendance but was still successful with 36 players. Our April 2023 Social Day currently has 47 entries. Benalla CC also hosts events for the NEDCA region, hosting the NEDCA GC Handicap doubles in September 2022 and the NEDCA Open GC Tournament in April 2023.

Pennant - The Benalla team had a very successful year. After being on top of the ladder for many rounds and reaching the finals, the eventual winners were decided on the last hoop of the day, in extra time, and unfortunately Benalla were beaten. Benalla has entered a team for 2023 Pennant series.

Club Workshops - Five of our members attended coaching workshops provided by Maurice and Sarina Cevaal-Hewitt.

Strengths - We are fortunate to have committed members who are very willing to contribute their time and energy to make our club a happy, successful one. Our courts are curated by a green keeper and kept in good condition.

Concerns - We are part of a combined tennis and croquet club - Benalla Lawn Tennis and Croquet Club. Maintaining our courts in top condition and upkeeping the clubhouse requires a lot of funds. Raising much-needed finance is an ongoing issue for our committees. Grants are constantly sourced with limited successes. Our clubhouse is in desperate need of major upgrades to the bathrooms and storage areas.

Succession planning is also problematic. Members either feel ill equipped to cope with the technological aspects of holding executive positions or have failing health. We are heavily reliant on the goodwill of a few people who give inordinate amounts of time to the club. Increasing our membership is a challenging necessity.

Twin City

Successful 2023 NSW Seniors Festival with six members returning. We have hosted intensive week long golf croquet coaching for visiting players.

Wodonga

Membership remains steady and we continue to hold regular social days that are well supported by other clubs.

Yarrawonga

Lawns have been refurbished and playing schedule resumed.

VCA – SEMCA REPORT APRIL '23

The six clubs that make up SEMCA cover an area from Point Nepean Park, home of Sorrento Croquet Club, to Frankston Croquet Club located in Frankston. The region also includes West Rosebud Bowls and Croquet Club, RNB, Village Glen and Mornington. Each club while enjoying their croquet is facing it's own challenges ranging from a lack of storage/clubroom facilities to internal committee/member issues and securing sponsors. However, despite these issues croquet clubs are generally attracting more players and members.

As the director for SEMCA I was very proud of our 2 players who represented our region in the recent Victorian Regional Tournament at Cairnlea. I wish to thank Janine Sisson (Mornington C.C.) and Bob Moir (Village Glen C.C.) for their efforts both on the days of the competition and in the hard work preparing for the tournament.

Our region does not have a strong record when it comes to running tournaments outside the club environment. Over a 12 month period we would probably see only 3 or 4 occasions when players outside our region are invited to compete in tournaments. At the last SEMCA meeting this was discussed and the group will be looking to see if it would be possible for more tournaments to be put into the calendar. Unfortunately, our problems are a lack of courts and to a small degree apathy. We only have 2 clubs with 3 courts, and only 1 of those is actively involved with SEMCA. There is one other club with 2 courts and the rest have only 1 court each with what might be considered a suitable surface with surfaces ranging from very good to a roughly cut public oval. Only a very small handful of players in our region participate in tournaments outside out region which leaves us with a very high percentage of social players.

Our players do generally mix happily between most clubs. With nearby clubs offering playing times when courts are under repair or being refreshed.

Mornington Croquet Club, a very busy club, is to be thanked for their flexibility. As one of the 2 clubs in the region they are always willing to do what they can to accommodate SEMCA requirements. RNB are continuing their work with community members with physical or health and wellbeing issues. On their behalf I would like to thank the Croquet Victoria Tournament and Fixtures Committee for allowing them to run the RNB Café at tournaments over the past few weeks. Thank you to Kate Patrick for her assistance in dealings with our local council. Thank you also goes out to Monash Croquet Club for providing courts, volunteers etc for their support in running the RNB "Odd Sock" Tournament.
