#### **FINANCIAL REPORT AUGUST 2023**

The following financial reports are attached:

- Detailed Profit and loss for five months ended 31 August 2023 against budget
- Balance Sheet as at 31 August 2023
- JBWere Monthly report Summary August 2023

#### Key points to note:

The Net Operating result at the end of August is \$77,329 compared to budget of \$52,059 and \$131,071 at this time last year. The overall result is \$137,648 compared to budget of \$71,459 and \$(158,690) at this time last year. The main differences relate to lower Investment income and lower expenses but higher positive market movement.

#### Income

- a) Tournament income for the month of August was \$1,645.
- b) The JB Were investment portfolio income YTD is \$70,617, \$15.4k lower than budget and \$36.9k lower than last year. Based on information provided by JBWere it appears that the difference to budget is mainly timing.
- c) The unrealised gain on the Investment portfolio YTD is \$60,419, \$41k higher than budgeted.

#### **Expenses**

- d) Administration charges are lower than budgeted due to lower Admin support than expected and some budgeted costs being paid from Grant money (e.g. budgeted website assistance of \$5k was charged at \$3.6K and paid from Grant money.)
- e) Tournament expenses for the month were \$890.
- f) VCC Building costs are lower than budgeted mainly due to less Repairs and Maintenance which is a timing difference.

#### **Balance Sheet**

- g) Net Assets at 31 August were \$8,951,337 compared to \$8,659,275 at August last year. The movement in Net Assets for the five months is an increase of \$137,648.
- h) See attachment for a summary page of the JB Were portfolio at 31 August showing the value of \$4,864,013, an increase of \$113,603 since the end of March.
- i) Accounts receivable is predominantly outstanding Affiliation fees.

# **Cash Outlook**

The operating bank account is \$153k at month end. This compares to approx. \$161k at the same point last year. There is no foreseeable need to draw any amounts from the Investment portfolio in the next quarter.

# Peter Coles Event sponsorship proposal responses from Croquet Victoria

1 Excellent to have an opportunity to compete at state and national level while still on a relatively high handicap.

Victorian figures for participation in events at Cairnlea are a bit better than the number cited - 144 Victorians competed in state and national events at Cairnlea last year. This was about 5% of members, and nearly half of the total for the whole of Australia!!

Pity to launch it and not have the \$ to continue. Would Croquet Australia continue it if the sponsorship isn't there?

Some of the \$0s in the budget look a bit iffy. Eg having each state provide an assistant tournament manager - or is it just one tournament manager when it's their turn? - for zero cost. We provide support in terms of travel, accommodation and meals. Ditto there are costs to providing referees.

Happy to see this scheme discussed further.

Yes, this event could be considered for the yearly calendar and would be a welcome addition to support the development of up and coming players.

**National Level format:** Rather than conducting the national playoff between the State representatives out of sync with the current GC Nationals (Gold Medal, Aust Women's and Men's Championships and the Interstate Shield), I propose that it be run at exactly the same time as the GC Gold Medal (either at the same venue if there are 3 spare courts available or at another venue to be used later in the Nationals). The event would effectively utilise some of the huge amount of work that has gone into preparing for the Nationals, rather than starting from scratch in another State.
