FINANCIAL REPORT JANUARY 2024

The following financial reports are attached:

- Summary Detailed Profit and loss for ten months ended 31 January 2024 against budget and prior year
- Balance Sheet as at 31 January 2024
- JBWere Monthly report Summary January 2024

Key points to note:

The Net Operating result at the end of January is \$56,917 compared to budget of (\$41,376) and \$154,425 at this time last year. The overall result is a surplus of \$262,394 compared to budget of \$(2,976) and \$33,664 at this time last year.

The main differences to budget are due to underspend on Administration (\$16.7k), Committee and Co-ordinators (\$20.8k), Junior Scholarship (\$5k), Repairs and Maintenance (\$25.2k) and VCC Court costs (\$16.6k).

ACA Insurance Income and Expense is also under budget as the ACA hasn't yet billed Insurance which is normally paid in January. The ACA has advised of a significant increase in ACA Insurance costs in 2024, from \$12.6k to \$17.8k. The increase relates to mainly to public liability. Whilst this has a neutral impact on our result, it is an increased cost to clubs/members.

The main differences from last year relate to lower Investment income (\$24.5k), lower premises hire (as last year included MacRobertson hire), higher legal fees (\$6k) and higher VCC Court Costs (\$22.3k).

The overall result is significantly higher than budget and last year due to large increases in Investment valuations over the past three months.

Income

- a) The JB Were investment portfolio income YTD is \$149k, \$5k higher than budget and \$24.5k lower than last year. Based on forecast information provided by JBWere we should meet budget this year.
- b) The unrealised gain on the Investment portfolio YTD is \$275k, \$237k higher than budgeted and \$394k better than this time last year. Over the last three months there has been a large positive movement of \$360k.
- c) Tournament income for the month was \$2.1k.

Expenses

- d) Administration charges are lower than budgeted due to continued lower Admin support than expected and some budgeted costs being paid from Grant money. However, as previously noted this has been partially offset by legal costs of \$6.6k relating to two tribunal matters.
- e) Committee and Co-ordinator spend continues to be below budget.
- f) VCC Building costs are lower than budgeted mainly due to less Repairs and Maintenance (\$25.2k) which is a timing difference.

g) VCC Court costs are \$16.6k lower than budget. However, over the last two months more Court assistance has been used and it is expected that this will be the case for the rest of the financial year, so we should get closer to budgeted spend.

Balance Sheet

- h) Net Assets at 31 January were \$9,145,528 compared to \$8,851,630.57 at January last year. The movement in Net Assets for the ten months since 1 April is an increase of \$332,239.
- i) See attachment for a summary page of the JB Were portfolio at 31 January showing the value of \$5,139,678, an increase of \$389,268 since the end of March.

Cash Outlook

The operating bank account is \$127k at month end. This compares to approx. \$171k at the same point last year. There is no foreseeable need to draw any amounts from the Investment portfolio in the next quarter.

President's report

BACKGROUND

Under the Constitution, the Committee of Management reports to Council via the President. Under the by-laws, the president is required to represent and promote mallet sports in all its forms throughout Victoria, to chair meetings of Council and CoM, and to attend meetings of subcommittees and working groups ex officio.

UPDATE

1. Matters from the Committee of Management

In January CoM met twice, with the second meeting devoted to financial matters. It considered

- Appointment of an Equipment Officer to coordinate loans of Croquet Victoria equipment referred to the VCC sub-committee
- Scholarships to support junior members attending the national Under 21 championships. Noted that James Wombwell came third in the national singles.
- Follow up to Council self-assessment and Skills Matrix
- Distribution of updated Ricochet rule books. Agreed that in line with practice in Golf and Association Croquet, accredited ricochet referees should receive a free copy of the new rule book.
- Status of current complaints
- The draft 2024-2025 budget

2. Promoting mallet sports

I recently attended Ballarat Western's celebration of its recent improvements in its courts, surrounds and clubhouse. The Mayor of Ballarat and two Council representatives were present and the Mayor ceremonially planted a horse chestnut tree. Ballarat Western's membership has risen by ten since COVID (currently 60); this was a very positive occasion.

On the first day of the Victorian Golf Croquet Singles, I contributed a brief interview on ABC regional radio. I have also been invited to be a studio guest on ABC Radio on Wednesday 14 February, to talk with David Astle about the language used in croquet.

3. Governance: complaints, self-assessment

COMPLAINTS We have still not heard that Croquet Australia has updated its complaints policies. This agenda includes an in camera item on complaints.

SELF-ASSESSMENT In January CoM discussed following up our 2021 Council self-assessment. Directors are being asked to complete a repeat of this survey via SurveyMonkey.

4. Representing mallet sports

By the time of this meeting I will have attended an update on Child Safe matters organised by Vicsport. Other Vicsport meetings have been in abeyance over the summer.

5. Liaising with Croquet Australia and other states

I have written to the other State presidents proposing that we get together via Zoom to catch up and share experiences. Waiting on their responses.

I have written to the CEO of Croquet Australia asking for updates on their complaints policies; their grants to clubs for increased membership; the documentation of their new logo; the distribution of Croquet Australia Board minutes; and the appointment of our grant funded organiser.

Strategic Plan Implementation Sub Committee.

The Strategic Plan Implementation subcommittee is pleased to present to Council updates to the Implementation Plan 2024. A link to the Implementation Plan (IP) is provided in this report. The TMA Final Action Plan has been forwarded as an attachment to this report.

As Council members are aware, the Sub-Committee role is to maintain an oversight of activities scheduled to be undertaken as strategic initiatives within the current Strategic Plan, as identified in the Implementation Plan. This includes Croquet Victoria activities which have been funded by the Victorian Government such as the Together More Active project.

Purpose of report:

Together More Active, Croquet Victoria Player Development Project Final Report to VCA Council, 19th February, 2024

The Croquet Victoria Player Development Project working group is pleased to present to Council the final report on the TMA project.

Background

In late 2019, the working group asked for interest from coaches to take on the role of lead coaches for this programme. The plan was to conduct a series of three 2-day workshops in both AC and GC at host clubs around the state. These workshops would cater for both novice and developing players in both codes. Material for the sessions was to be prepared by the coaches and delivered at workshops about 2 months apart. The coaches would be funded for preparation, travel, accommodation and time coaching from the Together More Active project grant that Croquet Victoria received from the Victorian Government.

Coaches John Van der Touw, Kenn Boal and Stephen Forster accepted the positions of lead coach.

Aims

There had been a noticeable reduction in numbers of players entering tournaments or pennant, with many preferring social club play. The project was devised to encourage players to develop their playing skills to make them more able to compete as well as to promote competitive play as an option for them. Many had not been exposed to advanced coaching and also were not aware of the range of competitions available to them.

A secondary aim was to encourage developing coaches in all regions, by showing them best practice coaching from experienced coaches. We also aimed to be able to provide them with the planned courses for coaching, prepared by our coaches.

Progress

After many months of planning how and where to deliver the project, the arrival of Covid put a stop to the plans, and until travel and congregating was safer, we were unable to continue. Finally, in November 2021 the first workshops were started, in Boort, Charlton and Elwood, with Bairnsdale following in January 2022. These covered both AC and GC at host clubs who had applied during the previous year. We were pleased to have so many clubs asking for the opportunity to host workshops and selected them from widely spaced regions, in both regional and metro areas in an effort to reach as many players as possible. In general, participant numbers were limited to between 15 and 20 players. This was because of the number of courts available and the size of the clubhouses but also for the benefit of the coaches. However, during the early sessions we soon decided that it was necessary for 2 coaches to attend, so we doubled up.

Coaches Maurice Cevaal-Hewitt and Kevin Beard joined the original lead coaches. The success of the workshops also depended on the enormous support from the venue hosts, in publicising the events, providing the player contact details, setting up the courts and clubhouse and being the centre of communication between the participants and the lead coaches.

During 2022 and 2023, further workshops were held at the original venues, and more sets of three workshops were completed at Ballarat, Ringwood, Williamstown, Warrnambool, Mildura, Brighton and Beechworth.

All told, we reached 182 players in 10 locations, in 8 different regions, from Mildura to Beechworth and Warrnambool to Bairnsdale. All workshops included players from nearby clubs; the total number of clubs reached was nearly 50.

In addition, as a result of this project, six clubs invited Maurice Cevaal-Hewitt to provide a GC coaching programme at their clubs, with a total of 74 participants: Bendigo; Eaglehawk; Shepparton; Wangaratta and Benalla; and Albury.

Feedback

Participants at the workshops were all given drill sheets for practice. They were asked to complete the drills in the first workshop, then again at the end. They also received workbooks to take home, summarising the material that had been covered at the workshops.

Participants were asked to complete surveys online or on paper, covering their experience at the workshop, opinions of the quality of the coaching, the material covered, and their own practice or competition play as well as any change in their perceived skill level.

Following the first (pilot) round of workshops, a 'host kit' of resources was provided to *host clubs* to help them prepare for the workshops.

Hosts were asked for any feedback about the organisation and expectations of them, as well as their experience of the workshops. Some provided written reports and some photographs.

The general consensus was that the workshops were very well received and in particular, the country players were pleased to have quality coaching come to them. Most participants stated that they had really enjoyed the workshops and most also attended all three. There was some difficulty

in grading participants before the coaching, so for some the content was a bit advanced beyond their level and there was a suggestion that a brief course for a total beginner would be worth delivering as well. There were also a few who found that the days were too long. These issues will be considered by coaches in any future rounds using this material.

Even more promising was the number of survey respondents that declared that their play had improved, in both skills and tactics, even though not all respondents stated that they had actually practised! Many had played competition, including local pennant and tournaments, but there was a clear indication that those who had not felt that they were still not ready, or that there was a limited number of opportunities in their area. Some had travelled a large distance to attend the closest workshop and found travel and accommodation costs a big factor.

Confirming our working group decision to double the number of our presenting coaches, players commented that they appreciated the personal attention and would like even more, although they realised that couldn't always be achieved with up to 20 players.

Participants were complimentary to the host clubs, who really did a great job of catering to their needs and that of the coaches who they were supporting.

From the coaches, there was a suggestion that teaching novice AC players on a half size lawn, particularly if the court is slow, would be better. There was a very pleasing result of the AC coaching for novice players, that several of those participants have been invited to the Development Squad for further training. Similarly, participants from the AC developing player workshops were winners and runners up in the Country Regional Championships in three sections! One of the metropolitan GC workshop sessions was not as well attended as many others, which was disappointing, given that other hosting applications had been received and we had not been able to cater to them all.

Funding

Together with the grant from the Victorian Government, a small charge of just \$20 per participant for the three workshop sessions meant we were able to deliver this intensive coaching course to a widespread group of Victorian players of both GC and AC.

There has been a further grant allocated to VCA, to contribute to coaching. From this pilot project we can see that expert coaching has a flow on effect, with participants in the project passing on their knowledge, enthusiastically involving their clubmates and beginning to take part in competition. This is even more evident in country regions, where further requests for coaching have been received and catered to.

The largest part of the expenses allocated for this pilot project was for the travel and accommodation for the lead coaches. With local coaches being trained and able to deliver this programme in further workshops, the costs would not require continual grant funding.

The player training material from this project can then be delivered locally and our players can be taught how to achieve success in this wonderful game.

Gippsland Croquet Association Report: February 2024


Drouin Croquet Club:

Our Courts are looked after by our greens team who also do other jobs that need to be done. We are also doing work to our club rooms

Our current membership at January 2024 stands at 25 and 1 Associate member – we've had new members join, old members resign, and the death of a long-standing member; so numbers have remained pretty static over the past couple of years.

We applied for and received grants to enable the boundary fence to be replaced during 2023; a new computer for use by the secretary; Quadway hoops; and sponsorship to go towards the purchase of sets of Dawson balls.

We have also replaced the blinds in the Club Rooms – looking good! Our courts/lawns have been cored during the year and are playing well, a few ongoing paspalum patches being dealt with from time to time.

We continued this year with Twilight Golf Croquet on Wednesday's during the daylight-saving period and this has been well attended.

In February 2023 Deirdre Lebbon was presented with a 25-year certificate as a member of Sale Croquet Club.

On Mondays Association Croquet now has eight members regularly playing – we continue to encourage other members to join us - to no avail!

Two of the local schools have come along with Year 10 students to learn to play Croquet – most of them enjoying themselves. We continue to participate in the Seniors Festival in October with 'Come and Try Croquet.'

Sale Croquet Club were finalists in the Golf Pennant for Gippsland and were successful in winning against Phillip Island Blue. We were also winners in the Association Pennant.

Morwell

We currently have 19 full and five associate members. Our numbers are in decline, our population ageing, and recruitment of major concern. Owing to this situation we were unable to field a pennant team this year which was sad because we really gave it a nudge the previous year. We were also unable to host any tournaments as the manpower just was not available.

That being as it may our courts are looking the best they ever have after we sought professional help and bought them up to speed. We hosted the Gippsland pennant finals in December and received many compliments about our lawns.

We only had one competitive player in 2023 who is the current Gippsland Regional Champion Div 2 and also won the Eastern Qualifier to represent Australia in the World Golf Croquet Championship Over 50's in Bunbury WA in October.

As previously mentioned, membership is a concern and we need to rethink our strategies on this issue, other than that the club is holding its own.

Wonthaggi

Currently we have 37 members, including two juniors. We will be actively encouraging people to join our club now that we have a new Pavilion. The pavilion, pathways and landscaping are now mostly completed and an official opening ceremony will be arranged at the appropriate time.

The club entered two Golf Croquet pennant teams in the GCA 2023 season, with one coming runner up in the West Gippsland section. We provided a qualified referee to officiate at the finals held in Morwell. Several members are regular tournament attendees (and raffle winners) and the club is hosting three separate tournaments this croquet season.

The club was a recipient of grants during the year. RSV provided funding for new croquet balls, and the Bass Coast Shire generously committed funds to assist the club purchase new, sturdy, lightweight chairs. We are also a registered donor under the Victorian Cans and Bottles deposit scheme. This allows members to direct credit to the club's bank account any refunds they may be entitled to, if they so choose.

Lakes Entrance

We currently have 31 full members, and one associate member, having lost one through transfer to Wonthaggi (lucky Club!), and gained 2 new members.

Our courts are in excellent condition, thanks to our volunteers and a steady summer rainfall.

We play Golf Croquet only, and our playdays at present are Tuesday (singles), Wednesday, Thursday and Sunday mornings. We have recently commenced Friday afternoon play with the focus on social interaction, and this is proving very successful, and there is likelihood of some new members as a result.

In November we had a Come Try Croquet afternoon, thanks to sponsorship from the Lakes Entrance Action and Development Association. Free BBQ, soft drinks and door prizes. Whilst 22 people came along, however it did not result in any immediate ongoing interest. However, there were a couple of primary school aged children who proved very keen, and we are intending to connect with local primary schools for possible inclusion in their early 2024 sports programmes. Sadly, secondary school students to date have shown negligible interest, so primary level may be of more benefit.

Our Come Try afternoon was strongly promoted on local social media pages and in shop windows plus Community messages on REG FM radio, plus word of mouth. Outcomes have proven that word of mouth, that is members bringing friends along, is truly the best means of promotion.

We had two pennant teams this season, and though not overly successful, the competition was nevertheless enjoyed.

We are in the process of gaining a grant to install a tournament office plus change room and extra toilet.

Our tournaments are very well run and popular, with full fields and players from all over Victoria. We are struggling, however, with our own Club events due to an ageing membership. This makes it even more important that we grow our membership by spreading the word about our Club and the great game of Golf

Croquet, all the while valuing and retaining our current members, many of whom were integral to Lakes Entrance Croquet Club Inc from its early days.

WARRAGUL CROQUET CLUB REPORT 2023-2024

MEMBERS: Currently 30 members – same as last year, we've had a couple leave and some join.

COURTS: Had a few problems with fungus patches but hopefully this will be under control soon. A new ride-on mower has made mowing an easier task, requiring about half the time. Baw Baw Shire Council is planning to build a retaining wall alongside one of the courts this year. Hopefully, that will start next month which means we will be down to one court for a period. We plan to take this time to work on the condition of the court.

PENNANT: Unfortunately we were unable to field a pennant team this past season due to a lack of numbers wanting to play.

TOURNAMENTS: Well attended singles and doubles tournaments in April and October. Singles tournament scheduled for April is already full with a waiting list.

SOCIAL DAYS: We have two challenge days per year. Twin Towns against Drouin – won by Warragul – and the Twin W'S Challenge against Wonthaggi – also won by Warragul. Come and try days haven't been fruitful.

SCHOOL GROUPS: We have had three groups of secondary school kids come.

ISSUES: The main issue we have at the moment is the problem associated with junior members (we have none, some may come from other clubs in the future, who knows) and visiting school groups. Due to the State Government's legislation requiring all clubs, etc, to adopt a Child Safe Policy which leads to members requiring to have working with children endorsement. The average age of our members is about seventy-two and there is real reluctance to obtain the WWC check. This means that there are only a few of us who are actually "legal" and sometimes the time commitment to these endeavours is tedious. Another issue for all clubs in the future, as I see it, is there will be people not willing to take on office-bearer positions as there seems to be more and more administrative type work involved. I sometimes feel like I need a degree in administration — if there is such a thing! Please note that's my personal gripe and not necessarily a club one.

TRARALGON CROQUET CLUB INC

Traralgon Croquet Club currently have 49 members (not all are active members).

2023 was a successful year - the club held successful Association & Golf tournaments, both doubles & singles throughout the year with good attendances. The club championships for both Association and Golf were held early in the year with quite a few members participating & hope to encourage more members to play in 2024.

We have gained some new members during the year, mainly by word of mouth. Sadly, two of our members passed away in 2023. Two new members to the club have re-located here from Tasmania & played for the New Town Croquet Club in Tasmania.

One of our members, Shane Downie, captained the Vic State Team last year.

The club entered 2 Association teams and 1 Golf team in the 2023 pennant season. A few Golf members played pennant for the first time in 2023 & are keen to play again in 2024.

The club successfully applied for a Latrobe City grant to extend our storage shed for extra green-keeping equipment. It looks very smart and fits perfectly with the current shed. Our "volunteer" green-keepers welcomed the extra space.

Our lawns are OK & the green-keepers are working hard keeping the weeds at bay – we do thank them for the wonderful job they do in rain, hail and shine.

In September the club hosted the Victorian Teachers' Games. The participants are past and present teachers & admin staff. It is a huge event and Latrobe City welcomed the games here in 2023. It was very well organised by the co-ordinators & they kept us well informed. We hosted over 90 players over 3 sessions - it was a lot of fun & a very successful event. The event will be held in the Latrobe Valley again in 2024 and we have once again been asked to participate as croquet will be on the list of sports being played.
